Lori Callahan is General Manager Liability and Compulsory Third Party Claims at Allianz Australia. In this role she oversees Public and Product Liability, Professional Indemnity, Directors and Officers and

Compulsory Third Party Claims for Australia and New Zealand. Allianz Australia is one of Australia's largest general insurers serving over 2 million policy holders and over 50% of Australia's top 200 BRW listed companies. Allianz Australia has just been named General Insurer of the Year by the Australia and New Zealand Insurance Industry Awards. Allianz Group is the second largest insurer in the world with 75 million customers in 70 countries.

Lori joined Allianz in 2002 after working with TressCox and Phillips Fox. Prior to coming to Australia in 1999, Lori was a partner in a U.S. law firm and was General Counsel for a U.S. Medical Professional Indemnity insurer. Lori has chaired an international claims committee and served on numerous law society and insurance associations. Lori was a founding member of a U.S. women attorneys organisation in 1983 and an annual women attorneys conference, which just celebrated its 20th anniversary. Lori has a Bachelors Degree in Economics and Juris Doctorate in Law.

In 2007, Allianz Group established the Global Diversity Council with a goal of increasing the number of women in senior management positions in Allianz companies around the world and increasing the number of women in the talent pipeline.

Lori will discuss how these diversity programs are being implemented in Australia and the successes to date of Allianz Australia in achieving its diversity goals.
